# Hey, Neighbor

he 1992 Field Trip has provided an interesting catalyst for the Oregon Country Fair in the area of neighborhood and community relations. Although it has long been a practice of the Fair to annually visit those with adjoining property, many more area residents have raised valid concerns about the impact we have on their small community. The OCF General Manager and the Neighbors Liaison Team are working with Veneta residents to address some of these issues. Our approach is concern and cooperation. We believe the result of our dialogue with the community will be a stronger and more positive relationship.

Patti Lomont has been the OCF Neighbors Liaison for the past eight years. Kathryn Madden joined Patti in this job in 1991. Prior to the Fair, we visit the immediate neighbors, listen to their concerns and work with them and staff to solve whatever problems we can. We are also on call during the Fair to respond to neighbors' complaints. Here are a few (com-

mon sense) suggestions for being a good neighbor this Fair season:

Please adhere to speed limit signs (5 mph) on Aero and Chicadee. These roads are transformed from sleepy little country lanes to major throughways when Fair activity increases, and the dust and noise is constant for those living along these roads. Five mph means 5 mph!

Be mindful of property boundaries and do not go onto neighbor's property. If you see someone doing this, please remind them that they are trespassing. Use Suttle Road and Highway 126 for access to our property.

It's a hot, dry year and we need to be especially aware of fire danger. The OCF Fire Marshall will issue guidelines as the Fair draws closer, but please be careful!

Finally, remember that most of us are temporary visitors in this community and that we must show respect and courtesy to the people who live here year round. If you have questions or concerns you may reach either Patti or Kathryn through the Fair office.



# Dead bash gets green light

"Our side" won (3-2), but if the Lane County Commissioners had their own way, it would have been 4-1 against, almost surely forcing the Grateful Dead concert into Autzen Stadium.

The May 20 vote climaxed four hours of testimony from more than 38 witnesses representing the pros and cons of permitting the event.

The Lane County staff produced a 22-page list of 27 health and safety conditions that Field Trip Productions must meet (mostly by July 1). An early contested point was whether the event was to be governed by local land use regulations (which would have allowed a negative vote), or by the state mass gathering law (which requires permit issuance if health and safety regulations are met).

Commissioners and legal staff agreed over the opposition attorney, Mike Farthing, that the mass gathering statute controlled the process. A variety of Fair officers and friends testified in favor. Some were from the Elmira area. About half the speakers (mostly from the site area) were firmly against the event. Recurrent complaints were about fire danger, massive illegal camping (trespassing), and inability of the local and Fair infrastructures to handle the projected 40,000 daily attendance.

In advance of the hearing, concert sponsors and their attorney, Bill Kloos, had met with county staff to shape the conditions and






# YOUTH STAGE

# **Public Forum**

As part of the Public Forum section of this newsletter we will be introducing a topic of Fair-wide concern each month with the hope of generating letters of opinions, feedback, and suggestions from you, the Fair Family.

This month we are introducing the topic of Population Control and ask that you send in your "Letters to the Editor" by August 5.

The subject of population control is really two-fold. Last year we had over 45,000 paying people attend our Fair. Was it too many? Did the sheer numbers affect craft and food sales for the good or bad? Did the path crowding and dust prevent the public and the family from enjoying the day-time Fair? Was our land negatively impacted? Did the Left Bank help to alleviate the crowding? If attendance was too large, how do you propose to limit it?

Some suggestions have been: limit advertising; sell advanced tickets only and/or closing the gate after so many sales per day (how do we deal with the people we have to turn away?); raise ticket prices; extend the Fair by one or two days or have two Fairs per year.

Maybe you don't think there were too many people and would like to see more. How would you propose to do that?




The second half of our population problem is, of course, internal. Are there too many people sneaking in? How can we correct that? Should we go to a wrist band policy? Should we have several sweeps, spot checks, tent searches? How do we justify significant others? Should everyone staying on site be contributing? Should we even have S.O.P.s? Should we try to generate staff positions for all legitimate Fair family members?

Should Teen crew be increased to accommodate all Fair family teens interested in the program? How do we determine the number of people needed to operate a crew? Should shifts be shortened or lengthened to limit or increase crew sizes? Should new crews be developed? Should crew sizes be linked to gate attendance?

Please respond to what is important to you. If possible, please separate your ideas concerning internal and external population issues. As a family, we need to communicate our thoughts and as an organization we need to direct our committees and our Board of Directors. Thank you.

day. By the mid-to late '80's, I felt the sweep was efficient and occasionally fun. I left the Sweep and joined the River Rats as Admiral Kohl.



The Oregon Country Fair, as a complete thought, is a world of its own. The things often left out by papers are the details that have made, and now keep, the Fair what it is.


It's a place where everyone belongs. It's a place where the grass is always greenest right where you're sitting, and the sky is always blue, even when it's raining.

As all good Fair family members know,t he legal language which governs our existence describes our organization as "volunteers," whose purpose as a non-profit corporation is based in "education and community service."

With the vision of community service in mind, and with the cooperation and support of our gracious general Manager, an application as submitted in late April to the Ste of Oregon Highway Division to allow the Oregon Country Fair to "adopt" the portion of Highway 126 from the intersection of Territorial Road in Veneta to Thomas Lane (MP44) 2.92 miles west.




the biotic and spiritual vigor of the Land. The committee has: 1) created a procedure to be used to evaluate and make decisions concerning all land use proposals for the land,

2) developed a process to solicit comments from each Fair crew on land use proposals, and 3) is identifying and mapping the


physical resources, currentlanduses, land use conflicts, future crew resource needs, and operating policies that affect land use.





John Stamp, Archaeology

In 1982 the Second Decadenal Grateful Dead Field Trip Concert was held at the Oregon Country Fair site. The money the OCF received from this enabled us to buy our land.

It was also during this period that work on the realignment of Highway 126 between Veneta and Noti revealed the presence of the vast archaeological complex of native residences, devel oped along the Long Tom River. Starting in 1979, and finishing in 1986, archaeological investigations by the Oregon Department of Transportation were conducted. The time and money—7 years and \$250,000—represents the largest investment yet on the study of the prehistoric peoples of the Southern Willamette Valley. The information obtained from this study proved that people have gathered here annually for at least 9,000 years, and possibly longer.

After having the privilege of participating in this project from inception through completion, OCF Archeology recommended continued research of the archaeological record. In response, our Board of Directors authorized our participation in an archaeological and geomorphological study. This project represented our first cooperative effort with agencies outside the OCF. The City of Veneta, the Oregon State Museum of Natural History, the University of Oregon's departments of Archaeology and Geography, the State Office of Historical Preservation, and the OCF contributed resources for this. Two University of Oregon graduate students-Dolly Friedel in Geography, and Lynn Peterson in Archaeology-received their masters degrees for their work.

The Veneta Archaeology Project revealed the oldest known human occupation yet discovered in Western Oregon, reaching back 10,000 years.

As a planning tool, this project enables us to avoid disturbing, when possible, or to respectfully study when not, the priceless archaeological resources in our stewardship.

In 1989, for the OCF's 20th anniversary, we began presenting this information at our living archaeology displays and demonstrations. Located on the Upper River Loop at Daredevil Meadow, "7,000" B.C. presents the latest in scientific information available on the prehistoric inhabitants of this land. Webring this information to life with our continuous demonstrations of aboriginal life skills, called experimental archaeology.

On November 3, 1990 the Association of Oregon Archaeologists honored the OCF with their first-ever recognition award for contributions to Archeology. In particular, they praised us for our extraordinary concern for preserving archaeological remains, and our efforts to communicate to the public an understanding and respect for those who lived here before.

A book describing the work the OCF has participated in will be available at the 1992 Fair. Please take this opportunity to learn what has been accomplished and to glimpse our vision of the future.





# Planning Fairly


So, you're coming to the Fair, aren't you? You want to see a realistic plan to get everyone checked in, don't you? Well, here's a well thought out attempt (we won't know how it'll be until the Fair) let's try it. If you are arriving before Friday, you can only enter through Aero Road, and only after 9 am. The registration booths (crafts, food, crews)

will be staffed from 9 am to 7 pm (when the gates are open). The security registration will be on the other side of Cabal Crossing in the wooded island by the Promised Land. Staff camping in the southern side of the property are asked to use the Back Staff lot to park and the Gaza Strip (old fire road) for access to their camping.

The Crafts Lot entrance has been moved so entry is not in conflict with foot traffic around the Dragon, and easier for all. People are Strongly Encouraged to make arrangements that will avoid bringing cars into the loop, and carpool, bike or bus if it's possible.

Please, Please, Please, don't bring a dog. People will break into your vehicle for humanitarian reasons. Those cars are perfect solar roasters. Fire is a physical and legal threat right now, so please avoid devices (unauthorized campfires, torches, flame throwers, etc.) that have open flames.

Please plan on extreme weather conditions (80° days, 40° nights), mosquitos and dust, so you may have 20/20 foresight. Welcome articles include: sun protection, warm hat & blanket, insect repellent/relief, patience, small penlights, chocolate, a cart, a smile, water & squirt gun. Remember, these are only suggestions, please have a good Fair. We are trying to help make it good for everyone!



agreements in the document before the commissioners. Attorney Farthing contended too many details were still lacking, but the commissioners delegated authority to staff to deny the permit (before or during) the eventiflater-detailed conditions were not met. The bitterest recurring complaint from locals was the OCF related trespassing—campign by Fair goers whom the locals felt would appear in even greater numbers at the Dead concert. People as far away as 3.5 miles related problems during recent years. Residents complained that the sheriff refused trespassing calls as "too low a priority." Commission Rust instructed staff to request the sheriff for this event to dispatch officers to such calls unless an actual emergency was in progress elsewhere.

With some additions to a wide-ranging motion, Commissioners Cornacchia, Rust, and Roberts voted in favor of the permit. Commissioners Frazier and Dumdi (voting against) felt conditions had not been met but they did not specify what change would sway them.

Chairperson Dumdi kept a tight lid on the often emotional testimony. Only the attorneys and commissioners were allowed to carry on dialogue. Regular citizens were allowed two minutes to speak, and questions to and from them were not allowed.

Ticket sales details are yet to be announced for the August 22-23 event. OCF rents the land to the produceers of the event. An attempt will be made to open earlier and close later the earlier-announced campsite space.





# On the Air...

For many years, Odyssey (and later its replacement, Fair Central) had POTS (Plain Old Telephone Service). Not until the first intercom connections were made did the Oregon Country Bell System begin to expand and serve its "customers."

The prototype intercom made its debut at a staff meeting in early 1981—two telephones, a battery, and a couple of pushbutton operated buzzers. The skeptical staff were heard to remark, "Sparks, remember, it's a Faire in the Countrie!"

Despite the lack of mutual enthusiasm, the phones were placed in Fair Central and the Main Camp kitchen, where, during the 1981 Fair, many steps were saved when someone wanted to know if so-and-so was sitting around the campfire, or who-z-whatzit could come over to Odyssey to deal with an irate path person.

Such a success required an encore, so for the 1982 Fair, two additional phones were added, one in Odyssey, another at Traffic Camp. To reach the extension one wanted, the button was pressed the number of times of that stations code, i.e., once for Odyssey, twice for Fair Central, thrice for Main Camp, etc.

The parties on the receiving end would have to count the number of rings, and pick up if the total equalled their code. Confusing, but connections were made and information flowed. Also in 1982, a switch was added to allow the POTS line to be connected to the intercom, allowing outside world calls to be sent and received inside the Fair.

The 1983 Fair brought 2 POTS lines to Fair Central, and an automatically canceling switcher to connect the intercom to them. This was the infamous "Beige Box," complete with many confusing switches and flashing indicators, which permitted us to

put people on "hold." What a feeling of complete power we enjoyed!

The OCB System was obviously growing, and to meet the increased demand, and make operation more intuitive, the big project of Winter and Spring of 1984 was to construct from scratch a Touch Tone decoder that would let us place calls by using the keys on a regular telephone. The system now would support up to 12 extensions, including Security, Registration, Solutions and others.

The phase-locked-loop tone decoders were prone to drift and required almost constant adjustment, but we were up and running.

One drawback of the system as it existed was the phones did not "ring," they "beeped," making a sound just like that of a local bird, and as a result many calls went unanswered until you went over to the station you were calling and told them to pick up the phone!

In 1988 upgrades were added to install a real DTMF (Dual Tone Multi-Frequency) tone decoder, lowering the overall rate of wrong numbers and incomplete calls.

Circuits were constructed and integrated into the tone decoder in 1989 to allow the use of a ring generator located in the caretaker's trailer that let the phones actually ring with their own bell. The circuits were designed to give a characteristic European "double ring."



The total number of extensions was expanded to 22 phones. The old phase-locked-loop and beeper system was put into service as the "Entercom" system, connecting various locations serving the Entertainment crew. The two systems were not interconnected, and at times, Fair Central personnel were seen with a handset to each ear, relaying information between the two systems to unseen staff.

Twenty-two intercom extensions makes for a very crowded party line. Most of the time it was busy. "Camping" was not uncommon; people would pick up the phone to make a call, find it busy, and just stay on the line waiting for the conversation to end so they could be the next to use it. Clearing the line for privacy or emergency calls to White Bird involved a good deal of shouting.

The 1991 Fair saw the end of these and other problems when we were able to rent a Mitel SX-20 PBX system and install it on site. This let us connect up to 8 POTS lines and 48 intercom extensions, allows up to 14 simultaneous conversations, call forwarding, busy signals, and integrates the Entercom system into the rest of Fair communications.

Through micro-processor programming, the SX-20 can tailor service to best suit needs, such as giving White Bird an outside line on demand, toll restrictions on most stations, and getting any of 3 phones at Fair Central to ring when you call Operator.

This year the budget committee has approved purchase of our own SX-20 and it will be in use routing all of our vital telecommunications.

I'd like to say it doesn't get any better than that, but given 11 years of evolution, the best might be yet to come. Next issue: Buried cable and how it got there.



### **Bylaw Article 5**

2. Eligibility and Admission. Any individual who subscribes to the purposes and basic policies of the corporation, who is registered with the corporation, and who has participated in one of the two previous years' Fair as a volunteer, worker, performer, or booth participant, may be deemed a member provided they abide by the terms and conditions of these bylaws, Articles of Incorporation, and any amendments thereto, and act in accordance with the decisions made by the Board of Directors.

6. Rights of Membership. (a) Voting: All members who have been members for at least 30 days prior to the date of a membership meeting shall be entitled to cast one vote in person on any issue brought before the membership. Members shall vote to elect the Board of Directors, recall a director, amend the Articles of Incorporation, as provided by the Oregon Revised Statues and by these bylaws.

### **COMMON QUESTIONS:**

1. Do I have to fill out a form every year?

NO! If you have completed a membership form, all you have to do is continue working at least every other Fair and keep your address updated with the Secretary.

2. How is membership verified?

On the form you are asked to give your role at the Fair-your crew or booth. Your crew coordinator or booth rep are asked to verify that you participated in one of the last two Fairs. If you move to a different crew or job, it is a good idea to fill out another member form to keep our info updated.

3. If you have my booth registration, doesn't that make me a member? No, registration is totally different from membership.

4. I'm on the mailing list to receive Board minutes does that mean I'm a member?

Not necessarily, the mailing list is totally separate from the membership.

5. I've worked at the Fair for years, so I must be on the list, right?

If you have filled out a membership form, yes. 6. How do I find out if I am on the membership list?

Ask your booth rep or coordinator. Before the '91 Fair the Secretary gave each of them a list of folks who have turned in membership forms that said they worked for them. If you are on their list and they have verified that you worked, then you are a member. If you are not on their list, maybe you are on another crew or booth list, this is possible if you have worked in more than one place.

7. Why do I have to fill out a form to become a member of the OCF? The 1989 Session of the Oregon State Legislature passed a law requiring Oregon non-profit corporations to keep a list of all members' names and addresses.

8. Does the Fair allow their mailing or membership list to be used for junk mail advertising?



### **AGENDA**

### FIELD TRIP

Motion: Steve G. moved to authorize and empower the Field Trip Committee to sign and execute the lease and agreement of the Fair property for the 1992 Field Trip. Daniel seconded.

Vote: The motion passed, 10 for, 0 against.

<u>Motion:</u> Steve G. moved to authorize the General Manager to accept under appropriate conditions a new well on the Fair property from the Field Trip organizers. Bob seconded.

<u>Background</u>: This is a gift from the concert promoters to the OCF. <u>Vote:</u> The motion passed, 10 for, 0 against.

### WINSLOW LAWSUIT

Motion: Steve G. moved to authorize the General Manager and the attorney to settle the John Winslow legal matter as described with an apology that states: "We are two friends who got in a fight. We both made mistakes, and we are sorry." Bob seconded.

<u>Background</u>: The Fair has reached a settlement with John Winslow of all his claims against the OCF.

Vote: The motion passed, 9 for, 1 (Anne) abstained.

### NEXT BOARD MEETING

Motion: Bob moved, Paxton seconded that the next Board of Directors meeting occur Sunday, July 5, 1992, 5 p.m. at the Fair site.

Background: Traditionally, the July Board meeting is held the first Sunday of the month at the site and this Board does not dare buck tradition.

<u>Vote</u>: The motion passed, 10 for, 0 against.

### RECYCLING CAPITAL IMPROVEMENT

Motion: Bob moved the Board authorize \$850 for lining the recycling pit with a movable structure. Thom seconded.

<u>Vote:</u> The motion passed, 8 for, 2 (Steve G., Steve W.) against. (If the vote was always like that I'd never get those guys mixed up.)

### **COMMUNITY RESPONSE TEAM**

Motion: Margo moved to authorize the General Manager to organize a neighborhood response team and expend up to \$500 for supplies, services, radios, and training. Kelly seconded.

Vote: The motion passed, 10 for, 0 against.

### KID'S LOOP

Motion: Kelly moved the Board release the \$2,000 put in reserve for Kid's Loop construction. Bob seconded.

Background: At the last meeting, the Board voted to hold \$2,000 in reserve for construction of play structures in the Kid's Loop. Kelly would like the money released to pay for building a climbing structure, 2 feet tall, with railings. She said Jill Liberty of Childcare supports the building of the structure, as does the LUMP committee. The Construction crew has volunteer to help build the structure.

Board Discussion: Thom would have liked to get the information in advance of the meeting. Margo asked for Board support of activities for children. Steve W., Daniel, and Steve G. are concerned about liability.

<u>Vote</u>: The motion failed, 5 for, 5 (Steve G, Steve W., Thom, Daniel, and Paxton against).

### WC FIELDS STAGE

Motion: Margo moved to authorize the General Manager to expend \$250 to construct a staging area for the relocation for the WC Fields vaudeville stage in the Left Bank for the 1992 Fair.

<u>Background</u>: The WC Fields stage has not been at a fit location for man nor beast, and the Entertainment crew would like to move it to the Left Bank this year and to the present site of the circus next year.

Vote: The motion passed, 10 for, 0 against.

(Bet you didn't know that WC 's tombstone says that all things considered, he would rather be at the Oregon Country Fair.)









#### COMPUTER HARD DRIVE

Motion: Margo moved to authorize the General Manager to expend up to \$700 to replace the hard drive for the office's IBM computer. Bob seconded.

Background: The hard drive on our IBM has died. We need another one or we're in database doo doo.

Public Discussion: The Computer Crew was encouraged to look at options and try to find a more inexpensive hard drive.

<u>Vote</u>: The motion passed, 8 for, 2 (Steve G., and Jeanne) opposed.

### SAIF CASE

Motion: Steve W. moved the Board authorize the Fair attorney to pursue the SAIF case to the Court of Appeals. Paxton seconded.

Background: The State Accident Insurance Fund has filed a claim against the OCF for the years 1987, 1988, and 1989, based on payment of food vouchers and per diem. Do we fight it or do we bite the bullet and pay the judgment? Although money to pay the judgement is in the budget, funds for legal fees to fight the case are not.

Public Discussion: Generally, the comments were in support of fighting the judgement, most people pointing out that if we don't, other agencies will feel more incined to sue us. Frank Sharpy pointed out that money for legal expenses will have to come from capital improvements.

Board Discussion: Margo feels we are one of the few non-profit organizations who can afford to fight this kind of suit and we owe it to the community to give it a try. Bob would like to get together with other non-profits on this issue.

Vote: The motion passed, 9 for, 1 (Jeanne) abstained.

### CONSTRUCTION BUDGET REQUEST

Motion: Paxton moved that the Construction Crew be given an additional 15 crew shirts, but no extra food vouchers or per diem. Thom seconded.

Background: Construction feels it needs 15 additional crew members in order to complete capital projects as well as its regular duties of setting up and taking down the Fair. The Board had voted at its last meeting to give the Construction Crew 60 shirted positions.

Board Discussion: Paxton supports the motion and feels the Crew has been overloaded with capital improvement projects. Bob would like to see a total number of 75 people on the crew, including those who get camping passes. Kelly, Margo, and Steve G. were concerned with the immediacy of the request, and felt the process was flawed.

<u>Vote</u>: The motion passed, 8 for, 1 (Jeanne) opposed, 1 (Bob) abstained.

### WHITE BIRD BUDGET REQUEST

Motion: Margo moved to increase the White Bird medical budget by \$800 in supplies and services for 1992. Bob seconded.

<u>Vote</u>: The motion passed, 9 for, 1 (Jeanne) opposed.

### VIDEO PROPOSALS

Motion: Bob moved to accept the following video proposals. Margo seconded. Proposal #1: Booth people and/or staff people may obtain (in their name) a restricted video camera permit from the video Coordinator with her/his approval, and by signing an agreement to operate within the Fair's video policies. Proposal #2: The restricted permit will allow recording of a specific domain. The specific domain for booth people is limited to their booth itself, the arts and/or crafts within the booth, the camping area, and the front of the booth and neighbors, as long as there are no objections from any subjects. Permit holders can even sit in the booth and tape the crowd, as long as no entertainers are present. The specific domain for staff people is limited to their camping area and the closely adjacent environment as long as they have consent from anyone who may be subject to the taping. Proposal #3: Entertainers and/or their representatives may be issued a restricted permit expressly for and limited to recording specific acts of those entertainers. Proposal #4: No one may capture on tape or film the image of any entertainer without their written approval. This includes any stage performance and any path performance and in any location on the Fair property. Proposal #5: No video cameras or film recorders of any type will be allowed for the paying public or for any non-booth or non-staff people. Proposal #6: The restricted permit does not allow anyone to roam the Fair with a camera. The permit must be attached to the camera at all times and is non-transferable. Written agreements are required for all permits. Violators will be subject to penalty of confiscation of their camera until the Fair is over at 7 p.m. on Sunday night. Proposal #7: The Video Coordinator may initiate and conduct projects for the Fair, within budget constraints, of course. Special permits will be issued for these projects. Proposal #8: The news media will be issued "media passes" for their video cameras. However, under normal circumstances all of the local TV stations should be allowed entrance for the camera, the camera person, and the reporter without hassle.

Public Discussion: Robert Aurnague DeSpain, Video Coordinator, said there will be 10 permits issued at the most.

Board Discussion: Daniel felt the issue was moving too fast (you mean on fast forward, D?), Kelly wondered how the policy would be enforced. Thom likes the proposals but thinks it is new business and actually an operations rather than a policy decision. Anne felt the proposals were making it easier to commercialize the Fair and takes away from the specialness of the event. Paxton likes the current policy and is not ready to vote on a new one. Steve G. feels this proposal allows entertainers to control all the taping and that confiscation of cameras is hard to do. Margo respects Robert's knowledge and suggests the policy be revisited if it doesn't work.

Vote: The motion failed, 2 for, 6 against (Paxton, Steve G., Anne, Thom, Daniel, Jeanne, 2 (Kelly, Margo) abstained.

Motion: Bob moved to accept with regrets Robert DeSpain's and Moz Wright's resignations as Video coordinators and accept their recommendation of Peter Johnson as their replacement. Margo seconded.

Vote: The motion passed, 10 for, 0 against.

#### CHILDCARE COORDINATOR

Motion: Bob moved to accept with regrets Mary Jo Garner's resignation as Childcare Co-coordinator and accept her recommendation of Jack Reynolds as a replacement. Margo seconded.

Vote: The motion passed, 10 for, 0 against.

### YOUTH STAGE CO-COORDINATOR

Motion: Kelly moved to name Anna Shipway as co-coordinator of the Youth Stage (formerly Next Stage). Margo seconded.

Vote: The motion passed, 10 for, 0 against.

### **SWEEP**

Motion: Daniel moved, Bob seconded that the Board approve shirts only for a 12 person supervisory crew to work sweep from 6 p.m. to 12 midnight on Thursday, Friday, and Saturday.

Background: Don Doolin, Security coordinator, explained extra people are needed to make assure the perimeters of the Fair are safe and the Sweep can be effective.

Public Discussion: There was much support for the Sweep and a desire that it be strong.

Board Discussion: Steve G. supports a strong sweep and is shocked that the sweep crew has been dissipated. Kelly would like to explore strengthening the sweep without adding more shirts. Anne appreciates the Security crew not asking for more than t-shirts. Margo feels she can't vote for the motion without talking to other Budget Committee members. Jeanne feels we need strength in numbers and that we all need to get behind the sweep (figuratively and literally, I imagine).

Vote: The motion passed, 7 for, 2 opposed (Kelly, Thom), 1 abstained (Margo).

Motion: Daniel moved, Paxton seconded the Board support the Security crew in restructuring the sweep to meet the needs of the Fair family, including requiring that passes be visible at all times.

Vote: The motion passed, 10 for, 0 against.

### COMMUNITY RELATIONS COMMITTEE

Motion: Anne moved to appoint Patti Lamont, Kathryn Madden, Daniel Dillon, John Doscher and Leslie Scott to a Community Relations Committee. Bob seconded.

Vote: The motion passed, 9 for, 0 against, 1 abstained (Daniel).

### LONG RANGE PLANNING COMMITTEE

Motion: Thom moved that the Board of Directors appoint Paxton Hoag, Serenity Maestes, Darrel Sink, Camille Cole, Lucy Kingsley, Don Doolin, Margo Schaefer, Steve Wisnovsky, Charlene Tremayne, Brian Alexander, Leslie Scott, Randy McCarley, David Wilson, Jim Campbell, Ray Sewell, Ron Lloyd, and Ann Marie Schultz to a standing Long Range Planning Committee; that this committee be requested to work through subcommittees on a series of long-range issues confronting the Fair, with a goal of presenting options for actions to the Board (after approval of the full committee); that the list of issues to be addresed by the Committee include, but not be limited to: overpopulation (growth), needs for land acquisition, potential for more/better use of the property, nurturing our land, community relations; that the Committee begin its work by drafting a proposed "Plan of Action," including a time line for dealing with these issues and presenting that plan to the Board at its September meeting. Bob seconded.

Board Discussion: Margo feels the Committe needs more guidance

from the Board.

Vote: The motion passed, 9 for, 1 (Margo) opposed.

### CARETAKER'S RESIDENCE

Motion: Steve W. moved that the Land Use Management Planning Committee begin the planning and permit process to build a caretaker's residence in consulation with the Caretaker, the General Manager, and the Budget Committee. Paxton seconded.

Board Discussion: Thom said the Board hasn't examined the options well and hasn't asked the proper questions. Kelly pointed out that money for permits has not been budgeted and the Budget Committee won't meet

The motion was tabled until July.

### PREFERENTIAL PURCHASING

Motion: Thom moved, Kelly seconded that at Jim Sahr's suggestion, when capital expenditures, especially major purchases of equipment or material are needed, the authorized purchasing agent/s for the Oregon Country Fair shall make a sincere effort to purchase goods and equipment manufactured by American companies, preferably, manufactured in locations of the following order of preference: City of Veneta; Eugene/Springfield metro area; Lane County; State of Oregon; Pacific Northwest.

Vote: The motion passed, 7 for, 3 opposed (Steve G., Margo, Paxton).
