Stop me if you've heard this before, but it's déjà vu all over again !

With donations from the Fair Family totaling \$13,241.52, and the Fair Board kicking in another \$10,000, contributions to this year's Jill Heiman Vision Fund totaled \$23,241.52, exceeding last year's previous record by \$942.67. This marks the fourth consecutive year that a record amount has been donated. Once again Fair Family members voted to award Vision Fund grants to agencies which provide Basic Needs care and services to homeless and/or low-income families, children and individuals within our community. Through the tremendous outpouring of generosity of our Family, the following five agencies will receive \$4,648.30 each to assist them in their efforts to offset the ravages of poverty, insufficient health coverage and homelessness which affect a significant por-

tion of our community members each and every day.

[1] **Shelter Care:** Expansion of Children's Program within the shelter for homeless families.

This year the Vision Fund reviewed 52 applications for funding, with requests totaling over \$250,000. As you can see, the unmet community needs greatly exceed our abilities to fund every request. However, the impact that each dollar donated and each Food Voucher dropped in a Vision Fund Box at the Fair have upon the uninsured, the homeless, the impoverished individuals, families and children is beyond simple math. It is impossible to compute the positive, healing effects that our financial support has upon the Spirit of the people who receive care and attention because of services provided through these donations.

[2] **Siuslaw Outreach Services:** Funding of direct aid and advocacy for round-the-clock Emergency Services for individuals and families in crisis.

[3] **Senior Meals Program:** Providing nourishing meals to seniors in Lane County. This Program operates 12 dining rooms and delivers meals to homes of seniors unable to travel.

[4] Lane County Legal Aid and Advocacy Center: This grant will help fund the Domestic Violence Clinic, designed to help stop violence against women in our communities.

[5] **SPS Student Dental Days:** Provides funding for restorative dental clinics to provide care for uninsured school-age children in the Eugene/Springfield area. 
Deane Morrow



I will continue to work toward involving the wider membership in decisions regarding allocation of excess Fair





RENAISSANCE ROOTS Buying the Land

Part I: Establishing legal status

(It has been 25 years since the Oregon Country Fair agreed to buy the land where the event is held each year. A lot of people worked hard to get the Fair to the point where an agreement was even possible. This Renaissance Roots article describes events leading up to the land purchase. It concentrates on that one main theme, leaving many good stories from the '70s for another time. This article was compiled from newspaper reports, Fair records and dozens of interviews with fascinating Fair folks. Many thanks to all who helped contribute to this story circle!)

Twenty-five years ago, Jill Heiman, who was the Fair attorney, and Ron Chase, who was Treasurer, negotiated for the Oregon Country Fair to buy the land where the event has been held since October 1970 (when it was known as the Oregon Renaissance Faire).

Ron Chase signed the promissory note stating the Oregon Country Fair's intent to purchase the property on July 8, 1982, the day before the Fair was held that year.

"It was huge news for us," says Robert DeSpain, who was secretary of the Fair Board at the time.

The story of buying the land winds its way through several important phases of Fair history: the establishment of the Oregon Country Fair as a tax-exempt nonprofit organization and Jill Heiman's successful lawsuit against Lane County Commissioners based on the Constitutional principle of Freedom of Assembly. The down payment came from some unusual sources, including the lawsuit

settlement and funds from the 1982 Grateful Dead Field Trip.

"Jill Heiman was a very influential woman in the purchase of the land and our right to even have this gathering," says crafter Ted Campbell (Cedar Flats Reunion booth). She'd gone toe to toe with the county commissioners and affirmed our freedom to gather, and that lawsuit actually helped contribute to the down payment on the property."

While Jill's involvement was instrumental, buying the land for the Fair was a longtime dream for many people who worked hard for years to see that vision come true.

Informal nonprofit benefits charity, not land fund

As early as October 1970, when the Renaissance Faire was first held along the Long Tom River, Faire organizers Bill and Cindy Wooten advocated putting money aside to buy the site.

The Wootens originally rented the property through connections with a friend, Connie Epstein Dineen, who had helped organize the Renaissance Faire on Crow Road earlier that year (May 1970). After that Faire, Connie asked Bill and Cindy Wooten to help organize the fall Faire, and Connie helped line up the new site. Friends of hers were renting a house there, on 400 acres that partially flooded three months of the year.

The Wootens visited the site with some friends to look it over. They found

Family Shelter — those kinds of groups got the money."

Ron Chase remembers that typically there would be 100 or 150 people at the post-Fair meetings.

Over the years, the site where the Faire was held continued to be offered for sale, but the event never made enough profit for a down payment. Meantime, parcels of the land were sold off for homes.

"Our heads were into community organizing, not real estate," Bill Wooten wrote in "Oregon Country Fair: The early years."

Cindy Wooten was pivotal to the Fair's organization, running all of the in-town operations, says Sandra Bauer, who lived at Bill and Cindy Wooten's house in the early '70s. Cindy "negotiated contracts with the city, hired entertainment, sold booth spaces — in those days we had a table down at Saturday Market and celebrated the 150th booth — and hosted the coordinators meetings at our house," Sandra says.

Main Camp begins & leads

Meanwhile, a core group of about a dozen volunteers went out to live at the site a month ahead of the event to start preparations. That group and the place they stayed came to be known as Main Camp.

"Pretty much Main Camp was the Board," Ron Chase says. "And then the Board expanded to include some coordinators, but they were pretty much hand-picked by Main Camp as well."

The core group of Main Camp was fairly stable throughout the '70s. "We were truly a collective," Ron says. "All decisions, including decisions around buying the land and the concert, were discussed at length by everyone." During the '70s, the Main Camp core group included at various times, in addition to Ron: Connie Epstein Dineen, Nancy Albro, Sandra Bauer, Mary Cay Liebig, Terry Patrick, Mike Kilgallon, Amy Kilgallon, Marcia O'Dell, Wally Slocum and Reese Prouty.

As the key organizers, Bill and Cindy Wooten stood at the center of group consensus, holding the organization together with their complementary skills and similar vision. But when Bill and Cindy got divorced in 1976, Main Camp workers say they struggled to fill Cindy's role.

"After they split up, it was hard on the Fair," says Wally Slocum (Banner Crew). "Cindy was the main person to get things done. Bill was philosophic to a flaw — he'd mull something over until the deadlines had all passed."

Ron Chase affirms that it was a difficult time. "There were a lot of struggles around this," he says. "We all got involved around their relationship. Bill was a visionary — he's a brilliant man. But — there's always a 'but,' isn't there — he wasn't all that useful in the day-to-day details of doing things."

"The year that Bill and I got divorced, he made life very difficult for me in terms of belonging to the Fair," Cynthia Wooten says. "Our divorce and split had a big impact on a lot of people at the Fair, and I regret that, but it was not anything we could avoid."

The Main Camp folks scrambled to pitch in, attending to the organizational details that Cindy used to handle.

"When Bill and Cindy divorced, it was Bill's contention that he would receive the Fair and Cindy would be gone," Sandra Bauer says. "The problem with that is that Bill had never done the organizing work. He was our philosopher and was a beautiful writer but he was not good at the nitty gritty. Suddenly the things that Cindy did were not being done. It was as close to a disaster as we had ever come and we might have lost the Fair that year (1976). Cynthia would come out to Main Camp and we would write up lists of things that needed to be done that she used to do and that Bill was not doing. That is the year that Main Camp took over the Fair.

a path along the river that would be perfect for booths. It intersected with another good path to a small meadow that could be used for the main stage area. Another clearing offered a good place for crafters to camp in.

The October 1970 Faire was a success and afterward, a meeting was called to discuss what to do with the profits. Faire participants reached

consensus to give the money to charity instead of putting it into a land fund, the Register-Guard reported. Bill Wooten later wrote in the Augur (an alternative weekly newspaper) that the proceeds from the October 1970 Faire helped fund a Thanksgiving Dinner event at First Congregational Church; funds also were loaned to the Wood and Fuel Co-Op to help pay for a truck.

Up until 1977, the Fair continued to act informally as a nonprofit organization, with many decisions made by consensus at pre-Fair potlucks. An annual meeting was held after each Fair to decide on community donations.

"After the Fair," Cynthia Wooten says, "the treasurer would make a report. ... And everyone who wanted to come ... decided how much money we needed to roll over to the next Fair and we gave the rest away to community groups. ... White Bird, Switchboard,

"Around this time, Jill and I shared a house and she started to get more involved in the Fair," Sandra says. "She was part of a group of us who 'lunched' every week or so at the Excelsior Cafe."

Jill worked primarily behind the scenes, Sandra says. Jill's legal practice focused on advising community nonprofit and co-op organizations as well as small start-up businesses around town.

"We had talked for years about being a nonprofit and (Jill) made that happen," Sandra says. On May 31, 1977, Jill filed the Oregon Country Fair for nonprofit status with the state of Oregon. That document lists the Fair's Board as Nancy Albro, Sandra, Jack Delay, Mary Cay Liebig, John Sundquist and Bill Wooten.

The first Board minutes also date to 1977. Those minutes record a number of clashes with Bill Wooten.

"We had some very contentious board meetings at our house that winter when we needed to finish dissuading Bill that he was in charge," Sandra says. "It was difficult for a couple of years ... (but Bill) eventually gave way to the new order of things."

Fair volunteers from the '70s agree that the original organization with Bill and Cindy Wooten was fluid and consensus-based.

"Everybody at the meeting could participate and have their say," says longtime OCF volunteer Jon Silvermoon (Community Village, Board of Directors, Dog Control). "Bill had a radical vision. ... Bill was really into cooperative organization." Jon contrasts this with Jill, who "had a very traditional vision, and it manifested itself in the way decisions ended up getting made."

But Main Stage emcee Denny Guehler believes the Fair organization actually became more open after the Wooten era. "The people that sort of formed the inner core of the Fair at that point were people that did open it up a lot more. Instead of everything being in Bill's control, it was balanced in a group of people. It needed to be opened up more," Denny says.



Elections begin

Ron Chase said many volunteers recognized that as the Fair considered buying the land, "the old methods of governance weren't gonna work and in fact shouldn't work. It needed to be expanded and it needed to be a much more broad-based governance structure. I resigned and a couple of other people resigned, at least their formal roles as board members. That opened it up to elections and to bring other people into it."

The first recorded election for Oregon Country Fair Board of Directors was held in April 1979. At that meeting, Ron Chase, Mary Cay Liebig and John Sundquist resigned from the Board, and Mary Wagner resigned as Treasurer. Elected to the Board were Mike Kilgallon, Mike Martin, Jon Pincus and alternate Paul Friedlander. Ron was elected Treasurer. Eileen "Lena" Stephens was elected Secretary. The new members joined continuing Board members Nancy Albro, Gil Harrison, Marshall Landman, Barbara Stern, Mary Wagner and Bill Wooten.

Time to incorporate

At the time, "we were moving into this attempt to find this governing board for a nonprofit organization," Reese Prouty says, "because that's when Jill Heiman came in and said, 'You know, if we buy this (land) up, we need to be a nonprofit corporation.' "

Jill first registered the Fair as a nonprofit organization with the state of Oregon in 1977. Two years later as the Board considered buying the land, she advised the Fair to file as a federal 501(c)(3) nonprofit organization in order to gain exemptions from federal taxes.

"When the Fair had to assume a legal entity," Ron says, "Jill was able to gently nudge that through, doing a lot of that work herself. ... She was the primary instrumental person in getting the 501(c)(3) (federal tax-ex-

empt designation), which was crucial to the Fair's future. Nobody else even recognized the importance of it, much less how hard it was to get it."

Jill proposed that the Fair apply to become a 501(c)(3) tax-exempt organization at the same meeting in September 1979 when the Board learned that "Aero/ Nelson may be interested in selling the property," according to the minutes. Mary Wagner wrote the original bylaws — which were required for 501(c)(3)organization — for credit as part of her coursework at University of Oregon's law school. Under the new bylaws, the Fair instituted a formal structure to elect the Board that specified membership voting rights and required annual membership meetings.





a Brigadoon-like village that demonstrates the values and ideals of an emerging, alternative culture.

After the approval of the Fair's tax-exempt status and the installation of an elected Board, Jill Heiman and Ron Chase were able to move forward with negotiating the purchase of the land. By then, the property was down to 240 acres out of the original 400 because it had been sold off in parcels to individual homeowners.

The Fair — here or there?

"The land was owned by the Western Aero Corp.," Ron says. "It was their retirement fund, their pension, this land investment. In fact, their principal guy named Bob Nelson ... told me ... that some of them were starting to get on in years and they wanted to sell the land and that we were the logical buyers. So we said yeah, we probably are. So we discussed it; the land was expensive and it was way overpriced considering that there was nothing you could do with it (because it floods every year). It's useless.

"He made honest efforts to farm it and it never worked," Ron says. "That thing lost money every single year. On the other hand, those of us at Main Camp felt pretty strongly that if the Fair had to move, it would never make it, that there was no way then that we could find another site, buy it, develop it and get through all of the regulatory and land use obstacles that we knew were going to come out in front of us. At least out there, in terms of the law, we were grandfathered in. Although there were lots of discussions about looking for another piece of land, none of them were ever serious, in my opinion. Those of us who were at the center of it knew that it was either that or nothing. And the negotiations went on for quite a while."

> Robert DeSpain says, "The Board decided to look around to see if indeed this was the piece of property, or if there was something else out there that we should be looking at. If we were going to have to move, then we were going to have to find something else. And if we couldn't find anything else, we were going to have to buy it.

"So I looked around, and I toundonepieceofpropertythat wasn't big enough, but it was a couple hundred acres out at Five Rivers, way out in the mountains, way too far away to expect the public to come, so that was out of the question. The other piece of property was in the middle of the Willamette Valley up by Halsey. It was a surveyor's screw-up.

Tax-exempt & living lightly

The IRS granted the Oregon Country Fair tax-exempt status in April 1980

based on its purpose "to preserve and foster regional cultural and artistic achievement." Jill wrote in the application that the Fair benefited the public by offering "cultural information, crafts and technical demonstrations including workshops and demonstration projects on solar energy, cooperatives, farming and music."

The Fair deliberately worked to provide a template for living lightly on the land and to provide a marketplace for crafters seeking to make a living outside of the mainstream, Sandra says. "This meant eating organic food, recycling, community development, women's rights, civil rights, and getting off the treadmill of the corporate world."

In effect, the IRS approved tax-exempt status to the Fair for creating

It was this piece of property that was 8 feet wide and a mile long. So we figured that we could put the booths kind of really close there," Robert says, laughing, "and there wouldn't be any parking.

"And then the third piece that was on the market at the time was that piece of property in Veneta," Robert says. "So we just went, 'OK, this is it. We are resolved, this is what we're going for."

Site Manager: Steve said his post-Fair mantra this year is "Business is Picking up," as in we're picking this up, we're picking that up, our work seems to be mostly picking up. Thanks to his fellow staff for pulling together and allowing him time off during Culture Jam and the Picnic for a family reunion. The rain that followed the Picnic refreshed the site and increased soil moisture, allowing for core plugging the paths after he returned. Coreplugging and reseeding the paths is essential to relieving the compaction caused by our Event. In spite of the rainfall, things dried out quickly and now all of Western Oregon is under a red flag warning for extreme fire danger. The Beaver Open gathering is in its 27th year, it has been here on the site for 3 years, thanks largely to Jeff Johnson and Dennis and Becca Ross of Flying Clipper footbag booth. It's a loose association of Hackey Sackers. There was lots of amazing talent here, including Hall of Famers and world champions. Our own Jeff Johnson (aka Animal) is in the Hackey Sack Hall of Fame. This year's gathering was about 125 multigenerational and well-organized folks who really know how to have fun. They like it here and want to stay and their volunteer work party just before Culture Jam really helped. Andyman will be away for family reasons for a week or two. There is a missing 10x20 shade structure that was set up by Maple Gate during the Fair. Board: Bear - This is the 16th straight year that this motion has been made. He thinks it will bring it to approximately \$400,000.

The motion passed 10 in favor, 0 opposed

Path Planning Proposal

Jack moved and Anna seconded that the board move to direct the Path Planning Committee to prepare options for the BOD in the event that circumstances warrant the relocation of 5 or more booths, change to the existing path routing or permanent performance venues. These relocation options to be delivered to the BOD for review by March 1 of any given year. If options are not provided by said date or prove unworkable, it shall become the responsibility of the Site Manager to propose options to the BOD.

Background: Jack - He has been paying close attention to the Path Planning discussion. The purpose of this motion is a bare minimum motion for what the board would need from the Path Planning committee and he is hoping that it doesn't interfere with the process but it is important that people understand what the board needs at a minimum to make these decisions.

Peach Gallery: John - Appreciates how this can be incorporated but this is a process question which would be better discussed at the workshop in two weeks. Dennis - Biggest frustration in working with PP over the years is the lack of consensus on long-term planning. For this motion to be effective it needs to be in the context of a 10-year plan. Suggests that the required yearly report submissions of a 10-year plan in which those changes fit is also mandated. Marlene - Applauds the idea of setting some concrete action out for the committee to follow. Joseph - In favor of idea of an annual report for the BOD for longscale development. Board - Lara - Likes alot about the motion; it speaks to the board's obligation, it speaks to direction...however with a worksession two weeks away wishes this would wait until after that. Won't support the motion until processes are discussed. Katie - appreciates this input, agrees with Marlene about expectations of committee, and thinks that this motion is premature. She wants to include it at upcoming worksession. Anna - Supports this and supports friendly ammendment of long-term plan that Dennis talked about.

Board Discussion: Paxton is opposed to this process. He thinks the makeup of the committee is going to be discussed at the workshop. The list here is different from what the original request of the planning committee was. Paxton moved to table this until after the October workshop. Dean seconded. Dean - thinks it would be good to give people more time to come forth. Lara - asked how many people so far? Bear - 13 people. The original proposal called for 7-16 people. The motion to table failed. 6 in favor, 4 opposed - Greg, Anna, Bear, Jack. Jack - When the board moved to create PP committee, it is now the board's responsibility to deal with that motion. Greg - This is perfect process. We appoint this committee now and they will know to come to the meeting. Anna - in the PP motion, were there any rules of engagement for the committee. Wonderful outpouring of support, she's concerned how many people on this. Who will track the committee, and who shows up and changing the membership and keeping it current. Bear - original motion did not include guidelines. Paxton - Dislikes appointing everyone who applies, thinks it's a flawed process. Hilary - agrees with Paxton. This is a working committee, should be a broad base of representation. Concerned that sometimes those who jump the

Bear moved and LT seconded to table motion until October BOD meeting. The motion to table passed 8 in favor, 2 opposed (Anna, Jack)
