## Intervention Training Schedule Change

## **OCF** Sex Offender Policy

The following motion was adopted as policy at the May 1994 Board of Directors meeting:

1. Adjudicated sex offenders who are not currently in, or have not successfully completed, a sex offender program with a licensed counselor, are not welcome at the Far as employees, staff, volunteers, contractors, entertainers or significant others.

2. Any person wishing to shall present documentation of an offense to the General Manager, who is granted the authority to bar said offender from entering the property, and may designate whichever crews necessary to enforce that prohibition.

3. Any coordinator or OCF staff person who is presented with aforementioned documentation will immediately report that information to the General Manager.

4. Any person barred from the OCF property may appeal exclusion through: a) the Grievance Procedure, or b) in June and July, when the Grievance Procedure is not in effect, the OCF president.

## Hey Buddy, Bring Your Buckets

Howdy Folks! First and foremost we want to thank all of the Fair Family for a great fire-free Fair in 2007. It's always gratifying to see so many people come together in a fairly flammable location and not have any significant issues to write home about.

The only instance that got our attention was already over when we heard about it, and involved a large vat of grease, fire, cool heads and the necessary equipment within reach to deal with the situation. Obviously, this could have gotten way out of control in a big hurry, but as the person we talked with stated, "we knew where our 5-gallon bucket with water and wet burlap and fire extinguisher were, so we were able to putitout immediately." We truly appreciate their rapid response. The only caveat is, if you take care of a situation, please give us a call immediately after it happens so we can investigate and use it as a teaching point for others. During our travels throughout the Fair and associated camping areas, we are just not seeing enough 2<sup>1</sup>/<sub>2</sub>- to 5-gallon buckets. The bucket is a great early suppression tool that is seriously effective in getting water on a fire before it turns into something we all don't want. We know the guidelines require two 5 gallon buckets per


camping area, one with water and one with water and burlap, but our philosophy is the more the merrier. Go ahead and get creative in identifying them as "Fire Only" but please get more out there. If you haven't already, now would be a great time to start collecting buckets for your crew or camp. There should be a fairly good supply at the Warebarn just prior to the Fair but not enough for everyone. All that we ask is that you give them a good home when you leave and of course, bring them back next year. We are planning on conducting fire extinguisher training for anyone interested on Saturday June 21st starting at 3 pm. We are not sure of the exact location yet, but it will be somewhere in North Miss Piggy's Lot. We will also offer another chance to pull, aim, squeeze and sweep (PASS) on July 4th starting around dusk somewhere along the route out to Pyrate's Cove. We'll have the fire tray and plenty of extinguishers available, so if you're around come on over. No matter what Mother Nature has in store for us this year, one thing remains constant; it takes a concerted effort by all to have a fire-free Fair and together, we can.





My father told me my mother quit smoking while I was in the womb. The last time I was at the Midnight Show I nearly passed out. Even small amounts of outdoor smoke make me feel so low I don't want to dance. Do you want to be at the Fair and not dance?

## Vision Quest Moves from Dreaming to Doing

Vision Quest moved into the next phase of on-the-ground implementation at a meeting May 18. In April, the Board of Directors approved nine goals that emerged out of the threeyear Vision Quest process. During the May workshop, about 60 people gathered to discuss the goals they are interested in implementing, and to figure out how to begin to reach those goals.

Summit facilitator Greg Rikhoff (Admissions Coordinator, former Board member and Vision Quest task force member) said the next step will be a lot like juggling. It's a handoff that will require skill and perseverance. While anything can happen, diligence and determination can keep things moving along. And there will be opportunities to refine the plan as it moves along. The first part of May's workshop focused on becoming familiar with the Vision Quest goals and with the history of the Vision Quest itself. Joseph Newton (Recycling Crew, Board alternate and Vision Quest task force member) said it all began several years ago when people started expressing an interest in creating a longrange planning process for the Oregon Country Fair. In November 2004, the Board authorized a Vision Quest task force to develop a process for creating a long-range plan for the OCF. Beth Grafe and Dedee Wilner-Nugent co-chaired the committee, working with the Board and the task force to survey members about what

the Fair's mission should be. With input from Fair Family, the Board approved the following intention statement in May 2005: "The Oregon Country Fair creates events and experiences that nourish the spirit, explore living artfully and authentically on Earth and transform culture in magical, joyous and healthy ways."

The first Vision Quest summit, also in May 2005, resulted in a list of priorities to help support that statement. The task force then surveyed Fair folks over the summer. In the fall of 2005, another summit was held to brainstorm about six goal areas that participants identified at the first summit and from survey results. Those goals remained relatively intact throughout the process, with a few areas expanded and other goals added in, as on-going surveying during the Fair and Board work sessions continued. The Vision Quest Task Force continued to develop processes for implementing the goals over the next year. A rapid illness unexpectedly took Beth Grafe's life in November 2006, bringing things briefly to a standstill. Then DeDee Wilner-Nugent stepped up from co-chair to lead the committee to complete its work, which was presented to the Board and approved in final form in April 2008. The goals are designed to guide the Fair toward its 50th anniversary.

9. The OCF shall improve its organizational effectiveness.

At the workshop, people brainstormed even more ways to reach some of the goals, so the refining process has already begun. In the afternoon, participants worked in separate groups, tackling a sample project that would help implement their chosen goal. Each group will present its report to the VQ Task Force, so please stay tuned about how you can get involved and how projects are progressing.



# It's a Hole-y Matter



Main Camp opened June 9 and the site is already buzzing with renewed activity. As people arrive to survey the scene, clean up the old

booth or begin constructing a new one, the looming question is always, "Can I dig this hole?" The answer is "Check in with Archaeology at Main Camp!"

As host to some of the oldest dated archaeological sites west of the Cascades, we have a unique duty to protect and preserve the land and its riches. Even though we are private land owners, these sites are regulated by state and federal law. Disregarding the laws disrespects both the Fair and the native peoples

of Oregon. It can only harm the Fair and make it harder for all of us. The State Historic Preservation Office requires us to keep a 30-meter buffer around any known site. Given the vast number of known sites and identified resources found throughout the Fair, the 30-meter buffer restricts most of the Fair to a "no dig" zone. You must follow the Guidelines and contact Construction and Archaeology before you disturb any

"You must follow the Guidelines and contact Construction and Archaeology before you disturb any ground anywhere on Fair property." ground anywhere on Fair property. In this regard, there is no such thing as "an old hole" or "grandfathering-in.' Failure to follow the Guidelines by anyone connected to your booth is cause to be put on notice. This could mean probation, suspension, or even immediate expulsion and banishment for you; none of us wants this to happen.

The OCF Archaeology Crew has been compiling information on the known resources at the Fair and would love to share this information with you. We

also need your help! The more information we can gather, the better job we can do preserving it for generations to come. Please stop by the Archaeology Info Booth in Main Camp or contact DJ at 541-740-2232 or Virgil at 541-744-7857.

## **Resist the Darkness: Keep Crafts Handmade**

There was a time, long, long ago in the early years of the Fair, when creative people just showed up with whatever things they had made that year. Though fun, those days are now gone. The Fair outgrew this simple form of spontaneity and evolved into an amazing and outstanding arts and crafts festival known nationwide, even worldwide, as a result of a selective craft jury system developed through the use of wellrespected judges who are a part of the Oregon art community but not a part of the OCF.

This system was put in place for good reasons: to preserve the high quality of crafts being brought to the Fair, and also to protect the rights of those crafters who have made the effort to get their craft approved. Many crafters at the Fair make their entire living from creating, producing and selling their crafts, and it is not fair to them for anyone to bring just anything to sell at the Fair.

The Fair is still essentially about creativity. Performers and crafters bring a lot of creative energy to the event every July, and this energy finds a way to spread itself over the whole community, inspiring the still-spontaneous annual remaking of our ritual space and our own renewed visions of our lives.

The Craft Committee believes this spirit of creativity is the heart of the Fair, both spiritually and practically. We want to celebrate it and see it proliferate. As such, we want the Fair Family to be more aware of something that threatens this spiritual core. We are suffering a kind of heart disease.

One of the clearest symptoms we see of this is the increased presence of imported and factory-made goods at the Fair every year. This is at odds with the proposed mission statement of the OCF: "It is the intent of the OCF to create events and experiences that nourish the spirit, explore living artfully and authentically on earth and transform culture in a magical joyous and healthy way."

The OCF Guidelines specifically state the sale of imported or factory-made goods is not allowed at the Fair. This is true both during the public hours and in the mornings and evenings when our family celebrates in private. A small number of crafters do try to put imported or by the Oregon Country Fair Craft Committee



manufactured goods out for sale during the public hours of the Fair. The Craft Inventory crew does everything it can to limit this. We encourage all members of the Fair Family to support this crew in their efforts to maintain the original vision, the authenticity of the Fair as a creative community.

But we are also concerned about what goes on during non-public hours, especially at night. Over the last 15 years or so, there has been an increase in the number of people selling a variety of imported and factory-made items after hours: jewelry, woodworking, clothing, tapestries, etc. Again, the guidelines prohibit any sales outside of booths at any time, but this does not stop people from laying out blankets along the path to hawk whatever wares they may have brought with them to sell. The problem is evident in some booths as well, with a remarkable changeover from daytime to nighttime displays taking place as soon as the sweep passes by, or even earlier.

We believe that such sales are corrosive to the spirit of the Fair. Again, many of the Fair's crafters make their living by selling their crafts. Money spent on imports is money that could be spent on local crafts made by our very own crafters. In addition to this, there is no way for anyone to account for the conditions under which imports are made. They could well be made under sweatshop conditions, perhaps even by the small and vulnerable hands of children.

You just can't say for sure.

Many crafters choose to keep their crafts on display and for sale at night. We don't have a problem with this (in fact appreciate those craft-


ers that work longer hours to provide their crafts for the Fair Family who are also working all day). Nor do we have a problem with crafters selling crafts they have made but which are not approved for sale during the day, so long as all such sales take place within booths and only after the sweep has gone by. We are, however, concerned that the sale of crafts not made by members of the Fair Family is beginning to eclipse what we see as the original creative vision of the Fair. The main point we want everyone to reflect upon is that sales of imports and factory-made goods are not in line with the spirit of spontaneous creativity. The Fair at its best is infused with a spirit of creativity. We want everyone at the Fair to experience an awakening of creativity, personally, socially, and cosmically. But the everincreasing presence of imports and factory made items at the Fair tends to dampen the possibility for this awakening.

Let's also be honest about how this situation has evolved over time: while it has been Fair policy for many years that the kind of sales we are talking about are prohibited, there has not been full enforcement of the guidelines in this area. We on the Craft Committee feel that things are beginning to get out of hand. The Fair is beginning to feel less like the idealistic space for spontaneous creativity it once was and more like a kind of "hippie mall" where all kinds of items are available no matter where they come from or who made them (and in what conditions) and in what part of world?

So, what's the solution? We on the Craft Committee feel the first step is to create an awareness of this situation and to decide what kind of an event we want this Fair to be. We see this as a problem which is getting worse, and if the trend we have seen over the last few years continues, we are afraid it is going to destroy what we cherish most about this "essential event" of ours. As you find your way around the Fair this year, please take time to consider our concerns, and let your friends and neighbors know how you feel. We feel that the heart of the Fair is at risk, and we invite each and every one of you to help us restore it to health. Resist the darkness, and stay true to the light of creativity that has led us so far and so well.

As a member of the Jill Heiman Vision Fund Committee, I am very excited to share with the OCF community the committee's selected organizations. As always, there was a flood of applications, all very worthy. the family stays in stable housing.

**Food for Lane County** is in need of a new convection oven to feed

**Florence Food Share** requested \$2,000 for purchasing infant food and formula. The cost of food is steep and "infant foods are no exception."

Yachats Community Health Clinic is a rural, non-profit health clinic serving mostly the elderly and low-income families. The awarded \$4,000 will provide medical services to those in the rural mid-coast area.

**ShelterCare** is an organization committed to ending homelessness. The \$4,000 will keep families in their homes by assisting with budget planning, help paying rent or utility bills, and following up to ensure those who need immediate food assistance. The \$6,000 will go toward the replacement oven and will provide support for the staff at the Eugene Dining Room. The Dining Room provides the opportunity to serve hot meals and "enjoy relationships with folks from all walks of life."

**Catholic Community Services of Lane County** requested funds to purchase prescription medications for low-income individuals. "We hope that the OCF will join us in helping our neighbors live healthier lives."

#### **Agenda Review**

During agenda review, Katie moved and Bear seconded that the Board move an item from new to old business so it could be discussed tonight: Amendment to Personnel Policies and Procedures Manual. The motion passed 9 in favor and 1 opposed (sorry but I didn't catch who voted against it).

#### Announcements

Katie said there is a vacancy on the Archaeology Committee due to the passing of John Stamp. If you are interested in serving on that committee, send a letter of interest to Ann Rogers at a.two@namewithheldbyrequest.com.

Lara talked about Recycling Crew's compost workday held June 1. She said they removed 4 yards of waste post-Fair 2007 and another 27 barrels on June 1. She passed around a jar of "jet black dirt" saying this is what became of "your paper plates, cornware, paper boats, cups and napkins from last year." She asked people to be careful when they dispose of waste. Read the signage and make sure you put compostables in the proper bins. The 4 yards and 27 barrels of waste they removed included batteries, diapers, glass, plastic and condoms. She said it's the Family not the paying public that's responsible for this waste and encouraged all of us to speak up for respecting the land. She thanked Andyman and all the volunteers who helped on June 1.

Diane has another grandbaby. Her daughter Shadow had a baby on May 22.

Bear said there will be camphost trainings at Main Stage at 2 pm on Saturday June 28, Sunday July 6, and Wednesday July 9. New camp hosts should attend one of the three trainings. Returning camp hosts are welcome but need not attend if they have already been to one.

Leslie announced that Intervention training is incorrect in the Guidelines; it is on Sunday June 29.

Barbara announced another mistake in the Guidelines. It gives the date of the Annual Meeting as Oct. 13 but it is actually Saturday, October 18.

Lara contacted me a few days after tonight's meeting and asked me to add another announcement. She had the sad duty to report the passing of "our dear sweet, always smiling friend and fellow recycler" John Vizard on June 4. She said, "I can't write any more right now because my heart is leaking out of my eyes."

#### **Approval of Minutes**

Katie moved and Carl seconded to approve the minutes of the May 2008 Board meeting. The motion passed: 10 in favor, 0 opposed.

### **Member** Input

Paxton read a thank-you letter to the Board from Phoenix Rising, a booth that donates funds to three food banks as well as the Jill Heiman Vision Fund. After receiving letters of thanks for their donations, they decided they wanted to pass on the thanks to the Board for providing "water and recycling/trash services, fire oversight, arranging for reefers, ice, VegManEcs, archaeology resources, six-packs, alliances with Lane County for restaurant licensing, sources for compostable kitchenware, registration, security and parking, administrative services throughout the year, and countless other ways."

### **Staff and Officer Reports**

General Manager: Leslie talked about her father passing last week and thanked everyone who has been so kind to her this past month, with special appreciation for the staff and BUMS for all their extra support and assistance. Many contracts were finalized in May, including LTD, WhiteBird, and the sheriff. She thanked everyone who attended the Coordinators Potluck, Brad and Indigo for hosting it, and Inventory Crew for distributing staff tshirts and stickers. She thanked the crews and staff on site for all the work they accomplished over the weekend; she really missed being there on Saturday but was attending her father's memorial electronically. She's also been working on marketing and public relations. She thanked Jenny Newtson for representing the Fair in Portland at Last Thurday on Alberta Street where Fair tickets were available. She said ticket sales are going well and she also announced that the Fair won the Mayor's Bold Steps Award for Sustainability. The prize includes \$5,000 worth of radio time this month to talk about the Fair's efforts. She thanked Charlie for all the time he spent working on the award application and said it will soon be available online as part of the sustainability page being developed. She thanked the crew of the Peach Pit which she said is "coming along very well." She said we had a great VQ summit, including lots of new faces, and thanked everyone who was part of that, and norma for working so hard on it. She thanked Robin who she worked with to interview staff for Culture Jam.

Administrative Assistant: norma said it was "good to see new people" at the Coordinators Potluck and thanked everyone for "fresh ideas and input." She talked about Suzi Prozanski's series of articles for the Fair Family News, thanked Greg Rikhoff for facilitating the VQ summit, and discussed the office move to Main Camp. In June the onsite office will be open Wednesday through Sunday; then open daily in July. Robin will keep the town office open Monday through Friday. She said all the entertainment schedules will be online "by the time you read this." She dittoed Leslie's thanks to Inventory Crew and Brad and Indigo for their help with the Coordinators Potluck. The Fair received a grant from the Lane County Cultural Coalition for the archives project. She thanked Registration Crew for "streamlining the wait/ share list." Teddy Bears Picnic is August 23 at 3 pm. She said, "Bring your own place setting, volunteer to help, see you out at the site!"

**Site Manager:** Steve said the weekends of May 24-26 and May

Susan Stamp (Registration Crew) requested that the Board consider changing the name of the Junction to Stamp Junction in honor of her late brother-in-law John Stamp. (John was a member of Tree Crew and also played an instrumental part in educating the state about the important archaeological aspects of the Fair site during the time the state wanted to run a new highway through Fair property.)

Keith Herchberger (Community Village) gave the Board a packet of information about medical, dental, and supplemental health insurance policies. He has an Oregon Health Insurer's license and is interested in making lower-cost policies available for Fair Family members to purchase. Joseph said "hats off and hearts out to you, Keith." Deane will work with Keith on developing a motion. Grumpy suggested they "run the wording" by the Fair's lawyer before bringing the motion to the Board. Keith apologized for some confusion resulting from his posting on the discuss list. He explained his idea is not for the Fair to provide health insurance for volunteers but for Fair family to band together to be able to purchase policies at reduced cost.

31-June 1 were very busy and productive for Site Crew, VegMan-Ecs, Construction, Recycling and others. He said spirits are high and things are going well. He thanked Andy, Jeff and Charlie for facilitating "so much work." Main Camp kitchen will have a commercial dishwasher which "isn't just about saving labor" but will also "use less water and produce less grey water." Tree Crew rented a 60 foot manlift (someone joked they should call it a personlift) which helps keep arborists safe and allows them to use all their energy on tree work rather than climbing up and down. He also thanked the Fair electricians, Jim Sahr and Michael Head. He advised people to be prepared for mosquitoes because "it appears to be one of those years." He mentioned reading a suggestion on the ocfdiscuss list for the Fair to provide onsite storage facilities for Fair Family who live far away. He said there are three commercial storage facilities in Veneta that are used by many in the Fair, and added that the Fair could still use more storage capacity for its own ever-expanding inventory of stuff. He talked about the phrase "reverence for the land" and said it is "disheartening that not all of us comply." He reminded us that all of us who wear a wristband are obligated to abide by the Code of Conduct and the Guidelines.

Assistant Manager: Charlie said the birdwalk at Wings and Wine split into two groups because it was such a big turnout. He thanked norma for organizing the summit and said he was "really excited" for the Fair to receive the Bold Steps award. He said the "whole Fair should be proud" but he gave "particular thanks to Leslie for her inspiration." Half of the ticket sales continue to be green tickets. He thanked Coordinators who are using the new computer system and said the "feedback is really positive." He thanked DeCon and Kitchen Crew and "thanks to Rainbow too and so many others I'm forgetting I'm sure."

**Office Assistant:** Robin said Culture Jam filled up in just three weeks and now has a waiting list. She was very impressed with CJ staff applicants who she described as "so willing, open, compassionate and inspired."

**Treasurers:** Hilary said this is "a tight budget year" and she put out a "plea to everybody to be really careful managing the budgets. Stretch every dollar." She remembers when the kitchen budget used to be about \$12,000 but now it's about \$50,000 and has a lot more people to feed. She reminded folks that the kitchen is meant to feed volunteers when they work a shift, and to please be supportive of the kitchen working within a tight budget.

**President:** Jack honored "the notion of volunteerism" and talked about "keeping our expectations modest" by being mindful that "less is more." He talked about reverence for the land and "being kind and gentle with each other."

#### **Committee Reports**

Archaeology Committee: Virgil Courtright read a detailed two-page report from the Archaeology Committee that touched many bases including their work on "maintaining the file of locations where archaeological material is located spatially within the grid system utilized by the OCF developed communications map." They will provide walkabout tours during Main Camp. They acknowledged thirteen booths in particular "for their support" and also listed six booths for their failure to follow Guidelines protocol: # 63 had a latrine trench not filled in prior to the 2007 Fair; # 900 did not talk to Archaeology about leveling and removing 6 inches of topsoil, and also buried pier pads incorrectly; #11 contacted Archaeology but did the work before they got there; and Numbers 913, 983, and 988 had "buried posts, not on piers." They are awaiting word from management on submitting the site form for the Black Oak site which lies in the warebarn/ sauna area. They also await grant applications to review before submitting the applications for archaeology grants from the State of Oregon. The oven "that has been eroding along Strawberry Lane is very visible right now and it would be nice to interpret this feature during Fair, which would add to some volunteers' workload" and discussed the necessary excavation permits and soil sample analyses. They have a vacancy on their committee due to the passing of John Stamp. If you want to join, contact Co-Coordinator Ann Rogers at a.two@namewithheldbyrequest. com.

Elders Committee: Chris Browne read the report from their May 22 meeting. They had an information table at Spring Fling. They put a notice about the Memorial Project in the FFN and are collecting names for the Project. They had another work party at Elders Camp where "several more camping sites were roughed out and fill dirt was added to help make them as comfortable and level as possible." They plan to set up "a conversation teepee and a small hospitality tent" in Elders Camp and "the Geezer Pleaser will be based there also." Their next meeting is at the town office on June 26 at 7pm. Crafts Committee: Lara read a report from Anita Parish updating the Board on what the Craft Committee has been doing. They sent a representative to the Elders Retreat and are "looking" at the idea of an Elders collective-type craft booth concept." They voted unanimously at the May meeting to recommend the Board appoint Justin Honea as a new member of Craft Committee. They are working with Registration to find placement for new and returning crafters. They are writing a report to the Board and the FFN about "the afterhours selling situation and the imports issue." Committee members have conflicting feelings on the issue and they asked for member imput. Write or e-mail them c/o the Fair office.

though she wasn't on the hiring committee, she understood they had "a number of very well-qualified candidates."

**Board:** Lara thanked her fellow hiring committee members and Palmer said it was a "good process but wasn't easy." Deane said he's glad Jeff will finally be an employee and Joseph congratulated Jeff who he has known for more than five years.

The motion passed: 10 in favor and 0 opposed.

#### Budget Issues – Adjust Line Items

#### Bear moved and Lara seconded that the Board move whatever money is left at the end of June in the Site Manager's site support line item to the General Manager's salary line item.

**Background**: The Treasurers requested this motion. Sorry if I don't understand this well enough to explain it, but I think this is more of a "housekeeping" motion, something to do with moving money around for the Groundskeeper salary. This motion does not ask for any new expenditure of money.

The motion passed: 10 in favor and 0 opposed.

#### Appoint Main Camp Security Co-Coordinators

Jack moved and Paxton seconded that the Board appoint Shelly Joseph and Pete Larson as Main Camp Security Co-Coordinators.

**Background**: Main Camp Security Co-Coordinator Don Doolin proposed two new Co-Coordinators, Shelly Joseph and Pete Larson aka Petey Bob. It will require no change in budget; the other Co-Coordinator Amos approves; and they discussed this and had it approved first by the GM.

The motion passed: 10 in favor and 0 opposed.

#### **Consider Donation to Tamarack Wellness Center**

Palmer moved and Carl seconded that the Board donate \$500 from the Board donation budget to the Tamarack Wellness Center.

**Background:** Sue Sherman, executive director for TWC, said she was "overwhelmed" to be at this Country Fair meeting and said, "my heart is open to you." She described some of the facilities like their "wonderful warm water pool" used by babies as well as seniors. They have a yoga program that includes one student who is 100 years old. Their letter to the Board states that the donation would be used to help support a summer fundraising concert on August 10 featuring performers Jami Sieber (who, as a cellist, won an award for Best Rock Instrumentalist) and Benjy and Heather Wertheimer (sacred chanting).

**Peach Gallery and Board:** Thumbs up. Marlene Monette (Alice's camp host) said they "offer many benefits to the community." Palmer said they have photo voltaics to heat the pool and they sell energy back to EWEB.

The motion passed: 10 in favor and 0 opposed.

#### Consider Donation to NRO

# Deane moved and Bear seconded that the Board donate \$500 from the Board donation budget to Network for Reproductive Options.

**Background**: Marti Black, coordinator and fundraiser for NRO, said NRO is a private abortion funding agency that serves lowincome women. They have used past OCF donations to build their community resource library which includes a wide array of topics. She brought an impressive 9-page list of available books to show to Board members. Their letter to the Board states, "In the past 4 years over 1,000 community members and students attended NRO slide shows and other educational presentations delivering information about disease prevention, fertility aware ness, contraception and self-examination." They provide abortion funding to low-income women and provide educational outreach to "underserved and marginalized women, ethnic minorities, prisoners, homeless and other women living in poverty." Board: Bear talked about people, including a former board member, who have received death threats for their work at other facilities providing safe and legal abortions. He said it's important for the Fair to show support for "this very important cause." Paxton likes the fact that their library includes books written in Spanish.

### **Old Business**

Budget Issues - Hire Groundskeeper

Katie moved and Lara seconded that the Board hire Jeff Johnson as the OCF Groundskeeper, effective July 1, 2008.

**Peach Gallery:** Lots of thumbs up, plus supportive words from Steve. Leslie thanked everybody who applied and said even

The motion passed: 9 in favor and 1 opposed (Katie).

### Consider Donation to Eugene Peace Choir

Deane moved and Diane seconded that the Board donate \$500 from the Board donation budget to the Eugene Peace Choir.

**Background**: Kathleen Piper, EPC secretary, said the choir is "mainly supported by its own dues and volunteer work" but seeks grants to help support their upcoming performance season. The past focus of the choir has been on songs of peace, social justice, and environmental awareness. They have branched out into monthly community sing-alongs just for "pure fun" and are involved in a public workshop given by John Gainer on "the gospel, spiritual, and blues roots of civil rights music."

**Peach Gallery and Board:** Leslie said, "Few things break down barriers like singing together; it's a great community-builder." Paxton heard them sing at Community Village and "appreciates their work." Joseph said it has "been a bad year for peace but a great year for peace work" and thanked them for serving "for a long time." (since 1984)

The motion passed: 9 in favor and 1 opposed (Katie).

### Appoint Check Signers

Bear moved and Deane seconded that the Board appoint three check signers through July 31, 2008: Denise Schadegg for the Key Bank checking account; Douglas Crow Sykora for the Pacific Continental Quartermaster account; and Kristine Donald for the Key Bank kitchen account.

The motion passed: 10 in favor and 0 opposed.

#### Consider Two Amendments to the VQ Goals Document

**Background**: Several amendments were discussed and voted on at earlier meetings but these last two were tabled until tonight.

#1: Joseph moved and Lara seconded that the Board amend the VQ goals document to include the following: The Oregon Country Fair will develop systems of cross-training, information sharing, and documentation of critical functions across all of our essential organizational functions in order to ensure continuity through personal transitions.

**Peach Gallery:** Hilary asked if this meant paid staff or all positions. Joseph said he "left it open but I don't think we want any part of our organization dependent on the individual." Leslie said there has been talk about ideas and systems for knowledge transfer, especially during times of transition, and that this motion "captures some of it." She apologized to Joseph for "not spending time with you this past month to hammer this out."

**Board**: Bear "supports this as is." Paxton said he "waffled" when it was introduced last month but "this is a simplified, more refined version." He sees this as "adjunct to other manuals" and said it "supports the goals of sharing information." Responding to some earlier comments questioning the wording, Lara said, "Joseph is damn good with words. The man writes eloquently." Jack supports having the information readily accessible through a database.

The motion passed: 10 in favor and 0 opposed.

#2: Joseph moved and Katie seconded that the Board amend the VQ goals document to include the following: The Oregon Country Fair will develop a code of Rights and Responsibilities for all persons who mediate the access of others to our events and programs.

**Background**: Joseph said this motion came about because of "rumors/complaints about what people have to deal with to get their pass or to stay on a crew. These are not positions of power or privilege but of responsibility."

**Peach Gallery:** Grumpy feels he doesn't understand it well enough. Hilary said it might be a better fit in the Guidelines rather than the VQ document. Leslie said it's "difficult to mediate cultural values and practices through a code, it needs to be through relationships. I would think about this more deeply."

Board: Bear agreed and will vote no. Lara supports the idea but

needs Board approval. The consensus seemed to be that it's a good idea because as Joseph said, one basic purpose of our donations is "the opportunity to highlight and promote the good works of other organizations."

The motion passed: 10 in favor and 0 opposed.

### **Revised Sustainability Commitment**

Danya moved and Lara seconded that the Oregon Country Fair reaffirm its commitment to developing and implementing sustainable practices. Each year a Board workshop will be held to discuss issues of concern and what practices or strategies we could implement to decrease or eliminate unsustainable practices.

**Peach Gallery:** Leslie said it "makes sense for us to explicitly state support for sustainable practices and is essential for us to move forward in this area." Grumpy said "we need more than just lip service and pardon me but this motion just gives lip service. We run a 3-day event that imports water and is hard to do in a sustainable way. Is another Board workshop the answer?" Robin said it's important to "just keep stepping forward." Leslie likes the openness of a workshop, the idea of inviting others and leading the community. Charlie said it's important "to continue the conversation" and supports the motion as "a beginning to get us to discuss this on a regular basis." In reply to Grumpy, norma said, "Just because we don't, doesn't mean we can't." Hilary said some crews have "made incredible efforts, the more we can do the better. Maybe we'll have a fleet of electric vehicles, who knows."

**Board**: Lara said she doesn't have a problem with the concept of sustainability as she feels humans used to live sustainably as hunters and gatherers very long ago when waste was produced but still easily absorbed into the environment. She said this motion is, as others have said, "a beginning" and added as she held up the jar of black dirt, "Education takes time and it took six years of learning to create this dirt out of what was once garbage." Danya said "not supporting the motion because we're not sustainable doesn't make sense; we want to become ever more sustainable." Jack said the word "sustainability" has "gotten too much baggage. We have to search our souls for ways to use less." He said some of us have been engaged with this for a long time, "some of us are back to the landers; and because you've pushed this so hard you got my vote." Katie is "reluctant to dictate to future Boards but this issue will be on the horizon for the foreseeable future." Deane said it was "just a thought" and suggested a committee might be more appropriate than a workshop. Paxton likes the distinction of a work session because it opens up the discussion. Bear decided to vote no because the motion "doesn't add to what is already in our Guidelines."

The motion passed: 9 in favor and 1 opposed (Bear).

### Amend PPP Manual

# Katie moved and Bear seconded that the Board amend the PPP Manual to reflect that the Office Assistant pay range is 2-1 to 2-7.

**Background**: Katie explained this is basically the correction of a typo but they were advised it needed a Board vote.

The motion passed: 10 in favor and 0 opposed.

The meeting adjourned at 9:25 pm. The next Board meeting will be held on Sunday June 29, 2008, at 4 pm onsite at the Yurt. The agenda, subject to change, will include the following tabled items: Budget Issues; Consider Donation to Southeast Works (Bear); Reactivate Survey Committee (Paxton); as well as the following new business: Appoint New Recording Secretary; Personnel Amendments Regarding Health Benefits and More (Katie); Incorporating Graduating Teens and Transitioning Elders into New and Existing Crews (Katie); Health Insurance for Fair Family (Deane); Craft Committee Appointment (Lara); Path Planning Committee Appointment.

agrees with Hilary that it doesn't belong in VQ. Jack said there's "no system that's going to make everybody happy." Danya dittoed, "sentiment right, not for VQ." Paxton agreed, "a better fit for the Guidelines." Joseph said the VQ goals document is "a vision of what we're heading towards."

The motion failed: 2 in favor and 8 opposed (Bear, Carl, Danya, Deane, Diane, Jack, Lara and Paxton).

### Loan Walkie-Talkies to MEMA

Palmer moved and Joseph seconded that the Board approve the loan of walkie-talkies to MEMA for events on July 20 and August 24.

**Background**: Last year the Fair loaned walkie-talkies to the Musicians Emergency Medical Association, a non-profit founded in 2006 to help musicians with uninsured medical emergencies. Palmer will again be in charge of security for the events. To contribute to the fund visit www.memafund.org.

**Peach Gallery and Board:** Leslie "presumed a signed contract as usual." There was some discussion about whether or not this
